Considered the assessment of your preparation and of your curricular requirements as written in the call of the Rector Decree Rep. n. 212/2026 prot. n. 77370/V/2 on 30th March 2026, the ranking has been approved by the Rector on 29th May 2026, Decree n. Rep. n. 341/2026 prot. n. 103803/V/2.

We remind that the Master degree course runs n. 35 places, therefore applicants from 1st to 35th place can enroll "under condition" till the submission of Italian language certificate B1 (deadline 30/09/2026).

ADMITTED PEOPLE are invited to follow the steps:

- 1. From 8th June 2026 to 12th June 2026 we open your pre-enrollment (You have to do nothing)**
- 2. From 15th June 2026 to 19th June 2026 payment of 52,00 euro**
You are expected to do the payment of 52 euro through the sportello PagoPa <https://www.cbill.it/internet-banking-en>
- 3. On 29th June 2026 we open the enrollment procedure (You have to do nothing)**
- 4. From 30th June 2026 to 6th July 2026, you can fill in the online enrollment form and do the payment of the regional tax and stamp duty (first instalment)**
You will have to enroll online and pay the regional tax and stamp duty ("tassa regionale per il Diritto allo Studio Universitario" and the stamp duty).
The stamp duty amount will be €16.00
The regional tax amount varies according to the ISEEU parificato value and is as follows:
 - € 130.00 if the ISEEU value is lower than € 26,887.93;
 - € 160.00 if the ISEEU value is higher than € 26,887.93 but lower than € 53,775.86;
 - € 190.00 if the ISEEU value is higher than € 53,775.86.

If the ISEEU parificato certificate is not provided at the time of enrollment, the maximum amount of € 190.00 will be charged. It is therefore advisable to request the ISEEU parificato certificate before the enrollment.

If students enroll without having requested the ISEEU parificato, they can still request it by **15th December 2026**. In this case, the University will obtain it directly from the CAF, then recalculate the regional tax provide the adjustment or refund of any excess paid.
