## **STEP BY STEP**

### **A. Enrollment and payment**

1- Complete the pre-enrollment form required by the University of Bergamo (starting from 1st April!): <https://sportello.unibg.it/Home.do>

2- At the end of the procedure, pay the pre-enrollment fee of 52,00 € (not refundable)  
Deadline for pre-enrollment fee: 29/05/2020)

3- Send the receipt to [studenti.stranieri@unibg.it](mailto:studenti.stranieri@unibg.it) (remember to specify your name; surname and which course are you interested in)

4- After payment of pre-enrollment fee you will receive an “Eligibility Letter” issued by Student Office ([studenti.stranieri@unibg.it](mailto:studenti.stranieri@unibg.it))

### **B. Declaration of Value and Visa Issues**

#### **1- Declaration of Value:**

Submit the eligibility letter received from our university, the Form A and the other required forms specified by the consulate to the Italian Embassy/Consulate in your Country to finalize the pre-enrolment by the deadline.

(Deadline of the application for “Declaration of Value” is announced by the consulate.)

#### **2- Apply at the Italian Embassy/Consulate for the Study Visa:**

Once the Embassy has confirmed to the candidate the pre-matriculation. Please note the Italian Embassy officers can ask the candidate for some information and decide either to issue the VISA within August 2020 or to deny the request.

### **C. Only if you have a positive reply form the Italian Embassy and get the VISA:**

1- A week before your arrival in Italy please arrange an appointment with the UNIBG Students Office ([studenti.stranieri@unibg.it](mailto:studenti.stranieri@unibg.it)) to submit your original documents and have some useful information.

2- After checking the authenticity of the original documents and the validity of the Visa and doing the payment of Regional fees (about 156,00 €) the candidate will be able to finalize the matriculation.
